JOB DESCRIPTION

Job Title: Children at Risk of Exploitation (CARE) Project Worker

Hours per week: 17.5

Job Summary:

The post holder will be responsible for the one to one & group support of young people at risk of or who are being sexually exploited. Awareness raising of sexual exploitation with young people, and occasional training for CSE with professionals with the CARE Coordinator.

Main Duties:

- Development & delivery of training to young people within the following settings: schools, youth groups, residential care homes, young people's hostels, and other environments.
- To undertake a full assessment with individual service users identified as being involved in sexual exploitation in accordance with Cornerhouse Policy, offering appropriate information and support.
- Plan and follow through interventions on a one-to-one basis for Child Sexual Exploitation using trauma informed practice.
- To offer support to groups of young people at risk of sexual exploitation.
- Promotion of the project to relevant organisations and development of appropriate referral systems
- Contribute to the development and implementation of both internal and external plans, strategy and policy relating to young people at risk of sexual exploitation.

- To continue professional development in CSE and trauma informed practice and language around CSE to best support victims of CSE.
- To offer advocacy and referral to other organisations where appropriate.
- To have an understanding of relevant National Policy and Guidelines
- To attend relevant multi-agency meetings, including MACE when required contributing to the ethos of partnership working on a local level.
- To work in a multi-agency way with professionals involved in one to one cases and group work.
- To ensure that all activity is recorded in an agreed format to meet performance monitoring standards, including outcomes and service user feedback.
- Contribute to the production of the annual report and other documents on the work of the project and organisation.
- To be fully conversant with/and implement the Information Governance Policies of Cornerhouse
